Initial conversations identify the scope based on previous industry experience and the individual needs of the Client.



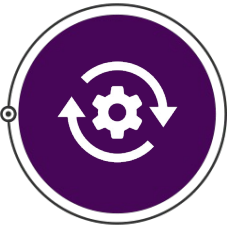
## Due Diligence
